Todos os detergentes solventes, lixívia, anti-nódoas disponíveis no mercado que não fizerem parte da NF para Revestimentos são de evitar. Limpar imediatamente algumas nódoas, como por exemplo as de tinta, café, vinho, eosina ou jeans, a fim de evitar a penetração na massa do tecido e permanecerem definitivas.

Atenção: não poderemos ser responsabilizados por problemas de migração ligados à má qualidade das tinturas. Estaremos isentos de qualquer responsabilidade por problemas originados pelo incumprimento das instruções de lavagem, utilização e manutenção.

Pour un entretien efficace, nettoyer régulièrement avec un savon au pH neutre et une brosse douce. Dans tous les cas rincer à l'eau claire.
